- 2017 OHV Planning Grant
 - Funding
 - Bob Bushanksy asked if there was any changes in the grant funding process.

 - Stakeholders Committee
 - Dan Keyes informed the committee of a Stakeholders meeting scheduled for Wednesday, June 27, 2018 @ 7:00 p.m.
 - Open Public Forum
 - Bob Bushansky spoke to the Public Forum being held during a Special MCRPD Board of Directors meeting on June 28, 2018 @ 6:30 p.m. at the Cotton Auditorium. He went onto discuss the anticipated format for the forum.
 - Economic Feasibility Study
 - Dan Keyes informed the committee that no additional updates from the consultant have been received.
 - CEQA Compliance Project
