4.1 State of California, OHV Planning and Restoration Grant Program & Projects

- A. 2018 OHV Planning Grant Application
 - Development of Stakeholders Committee
 - Sarah Huff requested for the minutes of the Regional Park Committee reflect public participation.
 - o Dan Keyes responded by stating that all minutes reflect public participation.
 - Bob Bushansky said the committee should be on the same page regarding the planning process.
 - John Huff in response commented that the Native Plant Society wants the EIR to be project and not programmatic based.
 - Sarah Huff provided an explanation of programmatic vs project and feels the request will cost the District more money.
 - Bob Bushansky feels like doing nothing is on the property will lead to more destruction.
 - John Huff said he EIR will show that we can't do nothing.
 - Sarah Huff emailed a copy of the Districts proposed stakeholders guidelines to all committee members.
 - o John Huff discussed the proposed stakeholder guidelines point by point.
 - Dan Keyes had questions about businesses vs property owners.
 - Sarah Huff provided an explanation.
 - Dan Keyes asked questions about the stakeholder group selection process regarding residents.
 - Bob Bushansky asked when the committee needs to be formed.
 - Sarah Huff responded with as soon as possible.

- B. 2017 OHV Planning Grant
 - Work Funded by Sign
 - Sarah has sent sign specs to Dan Keyes this morning.
 - Dan Keyes indicated he never received the specs and requested for them to be sent again.
 - Economic Feasibility Study
 - A general discussion was held regarding the information that was sent to MCRPD from Carl Ribaudo regarding red and green stickers. Statewide active registration of motorcycles and 3/4 wheel vehicles is 761,313. Northern California is approximately 105,000, Mendocino and adjacent counties 35,000.
 - o Bob Bushansky said we can only count on what we know is fact.
 - John Huff said outside tourism will be an important determining factor in the success of a future OHV Park.
 - Sarah Huff recited figures provided by the report completed by Don Amadon.
 - CEQA Compliance Project
 - Project is on schedule
 - Grant Revision
 - Sarah Huff also had an opportunity to talk with the State Grant Administrator regarding the grant reallocation request to hire a Public Information Coordinator and the grant administrator didn't feel like it was going to be a problem.
