### 4.0 DISCUSSION/ACTION

- 4.1 State of California, 2017 OHV Planning and Restoration Grant Programs
  - Sarah Huff discussed the pending site visit from State Environmentalist who are scheduled to be on site at 8:30 a.m. on Thursday, October 5, 2017. Dan, John and Sarah will be on site to meet with the State reps. Grant Administrator "Walt" will be retiring soon. MCRPD will be transferred to Jennifer Davis. Concerns were shared regarding Ms. Davis's knowledge of the program.
  - Bob Bushanksy recapped the State OHV Grant Administrative team.
  - Sarah Huff added to the list with even greater detail.
  - A general discussion was held regarding the attributes of effective leadership on this particular team.
  - Bob Bushanksy summarized the grant time line and potential benefit to the new grant administrator.
  - Sarah Huff talked about SB249 which provides permanent grant funding and was signed into law by the Governor.
  - A general discussion was held regarding State OHV fund lobbying efforts that took place to help ensure future funding.
  - Bob Bushanksy had questions about the results of a positive site visit.
  - Sarah Huff said that a positive site visit could result in a "sign off" as early as Thursday, October 5, 2017.
  - Bob Bushanksy discussed merits of financial impact of future OHV park operations and how it
    was important to for the COFB to take this potential into consideration when developing future
    growth and development plans.
  - Sarah Huff had questions regarding whether there was any legal issues with sharing information between surveyors and the other bidders.
  - Dan Keyes recommended that sharing not take place during a closed bid process and that all
    questions should come through the District Administrators office.

- Dan Keyes provided an update on the RFP development and publication process.
- Bob Bushanksy had questions about the time line for land planning.
