3.0 INFORMATION/DISCUSSION

3.1 Update staff on the history of the property and associated grants.

- Bushansky said that he has been thinking about the things came up this morning at the Special meeting. He said the way the fence bid had been was maybe done incorrectly.
- Marshall added that he knows the State is going to run the clock out on the grants and we will likely not see any satisfaction from them.
- Bushansky asked the status on the pre-application with the county. Just today, staff had received the application back requesting the check in full for the conference.
- Marshall said he thinks the state is feeling some heat from the Blue-Ribbon Coalition,
- Bradley said that the term that keeps getting used by the State is "self-dealing" and is unsure how that is applicable for the Board.
- Bushansky asked about the Blue-Ribbon Coalition and what is going on on that front.

- Sarah Bradley responded that she would gladly give more information as it comes, but things have been slowed way down the past 3 months due to COVID-19.
- Bradley said that she was of the thought that the State Parks never had a case brought to the Attorney General's office. She has checked with them and there is no record of it. This goes against what the State Parks has stated.
- To get in good standing with the State, there are things beyond OHV that need to be taken care of that go back to 2011 for the transfer of the CV Starr Community Center to the City of Fort Bragg. Measures have been taken to remedy that situation.
