# 4.0 DISCUSSION/ACTION

4.1 State of California, 2017 OHV Planning and Restoration Grant Programs

- Dan Keyes introduced agenda item summary 4.1
- General discussion was held regarding timeline for making a recommendation to the MCRPD Board of Directors for the disposition of the Regional Park Property.
- Bob Bushanksy spoke to the subject of public relations and perceptions by the public of government process. He used the Pygmy Forest contained within the regional park and possible associated supportive groups as a reason to garner support. Emphasized the need to have our talking points are the same focus as the terms of the grant. Suggested an article in the South Coast newspaper to help foster this notion.
- Sarah Huff emphasized funds can only be used for specific items.
- John Huff said that it was important to look at the dollars associated with the preliminary economic impact. Is fully aware of the public relations component associated with the grant.
- Jill Rexrode had questions about the financial requirements. Identified obligations and discussed requirements for the September timelines.
- John Huff talked about preliminary concept of an OHV area who we are catering to those who are either support the development of an OHV area or who do not.
- General discussion regarding potential stakeholders and how we communicate with them.
- Bob Bushansky urges consistency with the message.
- Sarah Huff said the EIR will be the determining factor.
