# 4.0 DISCUSSION/ACTION

- 4.1 State of California, 2017 OHV Planning and Restoration Grant Programs and Projects
  - John Huff said he would make a statement to the MCRPD Board of Directors at the 12-13-17
    meeting in regards to the procurement process and the Regional Park Committee's support of
    SMG as the consultant for the OHV Planning Grant Economic Feasibility Study.
  - Sarah Huff provided an update on the existing District match for the OHV Planning Grant.
  - Bob Bushanksy had questions to Sarah Huff regarding the grant reporting process and asked how long the CEQA Compliance and Economic Feasibility studies will take?
  - Sarah Huff responded by saying that both studies should be completed within six to nine months.
  - Bob Bushanksy had questions to Sarah Huff about other expenses for the planning grant.
  - Sarah Huff provided a detailed account of remaining planning grant expenses and the District's match.
  - John Huff provided clarification in regards to the grant funds used for survey work.
  - Bob Bushanksy was not sure what direction the Regional Park Access Control Project will go
    until the legal issues are resolved at the closed MCRPD Board of Directors meeting scheduled
    for 12-13-17 at 4:30 p.m.
  - John Huff discussed his recent experience in Washington and how the Design-Build process is a preferred procurement method.
  - Bob Bushanksy recalled a conversation he had with MCRPD Board member Bill Hayes about the fence design.
  - John Huff talked about status of the fence project and had questions about the legal opinion regarding the design build process and went further to say that CEQA doesn't consider the fence a project.
  - A general discussion was held regarding the definition of project and what were the ramifications of moving forward.

- Sarah Huff spoke to the Habitat Conservation Fund Grant and provided details in regards to the timeline and informed the committee about her most recent conversations with the grant administrators. She went further to say that the State was not responding to enquiries regarding the HCF Grant and discussed possible solutions.
- Bob Bushanksy believes we need to escalate the communication to receive an appropriate response.
- John Huff suggested contacting the grant administrator's supervisor.
- 4.2 State of California, 2017 Cal Recycle Grant Program and Projects
  - Sarah Huff reported that no further action has been conducted by the State relative to this grant program.
