4.1 MCRPD financial statement, September 2017

Line 6 on the income statement needs to be reviewed, it appears to contain a formula error on the excel spreadsheet. Line 17 should be titled Kudos and Assets. These errors will be reviewed and explained at the regular board meeting.
- It was requested that the Kudos and Assets line items are separated from the regular income statement and have their own category on the bottom of the statement. Total Revenue MCRPD, Total Revenue Kudos and Total Expenses MCRPD, Total Expenses Kudos.
- Bushansky asked if we found out if the check registers are necessary to include in the packets. Jill will be asking the auditor and reporting back.
