# **EXPLANATION:**

On September 29, 2021, at a Special Board of Directors Meeting, MCRPD Board passed Resolution No. 21-04 MAKING THE LEGALLY REQUIRED FINDINGS TO AUTHORIZE THE CONDUCT OF REMOTE "TELEPHONIC" MEETINGS DURING THE STATE OF EMERGENCY.

To participate in remote meetings, public agencies must comply with the requirements of Government Code section 54953. A requirement of section 54953 is that every 30 days the Board by majority vote must decide if the conditions that existed to pass Resolution 21-04 are still in existence; "such meeting is only allowed if it is during a state of emergency proclaimed by the Governor and the legislative body has made an initial determination of whether "as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees." July 15, 2022 will be 30 days.

# RESOLUTION OF THE MENDOCINO COAST RECREATION AND PARK DISTRICT BOARD OF DIRECTORS

# THE CONDUCT OF REMOTE "TELEPHONIC" MEETINGS DURING THE STATE OF EMERGENCY

**WHEREAS**, on March 4, 2020, pursuant to California Gov. Code Section 8625, the Governor declared a state of emergency; and

**WHEREAS**, on September 17, 2021, Governor Newsom signed AB 361, which bill went into immediate effect as urgency legislation; and

**WHEREAS,** AB 361 added subsection (e) to Gov. Code Section 54953 to authorize legislative bodies to conduct remote meetings provided the legislative body makes specified findings; and

WHEREAS, as of September 19, 2021, the COVID-19 pandemic has killed more than 67,612 Californians; and

WHEREAS, social distancing measures decrease the chance of spread of COVID-19; And

WHEREAS, it is appropriate for this body to make the findings specified in subsection (3)(1) of section 54953, to thereby authorize this body and all of its standing subcommittees to meet remotely;

**NOW, THEREFORE, IT IS RESOLVED** by the Board of Directors of The Mendocino Coast Recreation and Park District as follows:

1. This legislative body finds that as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.
